### Project Description

The Poverty, Reforestation, Energy and Climate Change Project (PROEZA1 ) will improve the resilience of 17,100 households that are highly vulnerable to the impacts of climate change (CC) in 64 municipal districts located in eight departamentos of Eastern Paraguay. These municipal districts have been selected because their environmental and social vulnerability is rated as extremely high<sup>2</sup> . Per IPCC climatic scenarios and the baseline information on the impacts of CC on people's livelihoods and ecosystems (see Section C.2), it is estimated that climatic variations would have significant and differentiated effects and intensities in various sectors. In particular, family farming would experience significant reductions in productivity in crops such as cotton, bean, cassava, sesame and sugarcane. Reduced productivity leads to a change of production type and can have important livelihoods impacts as well as social, environmental, economic and cultural effects in the rural sector that can ultimately impact resilience to CC.
