# **Project Description**

The Cerro Pabellón geothermal power project is being developed at the Apacheta geothermal concession, 1,300 km north of Santiago, at an altitude of 4,500 masl. Enel Green Power Chile Ltda and its parent company Enel S.p.A. are seeking financing to invest in the building of an up to 48 MW power plant and 80 kilometer (km) transmission line to interconnect to Chile's Sistema Interconectado del Norte Grande (SING) at a total cost of US\$320 million. Commercial operation of the power plant is expected to occur in the first half of 2017.

Cerro Pabellón is the most advanced geothermal project in Chile, with four deep exploratory wells already drilled between 2009 and 2010. The next stage of development involves work-overs of two existing wells as well as the drilling of five additional production wells and two reinjection wells (the "Drilling Program"). The Sponsors have requested financing from the Inter-American Investment Corporation (the "IIC") in its capacity as administrator of the Clean Technology Fund (the "CTF") in the form of a short-to-medium term loan during the Drilling Program (the "CTF Loan"). If the Drilling Program is not successful, the CTF Loan would be converted partially or fully to a grant. If the Drilling Program is successful, the CTF Loan must be replaced by long-term debt or repaid by the Sponsors.
