Project Description

This project finances the strengthening of national and regional cross-sectoral capacity for collaborative disease surveillance and epidemic preparedness in West Africa, including the ability to provide immediate and effective response in the event of an eligible crisis or emergency. This includes four main components: i) support for the enhancement of national surveillance and reporting systems; ii) strengthening of laboratory capacity; iii) preparedness and emergency response; and iv) human resource management for effective disease surveillance and epidemic preparedness.
